DISPLAY OF MEASURE RATES IN REPORTS

When displaying measure rates from the Licensed Measure Specifications on any **external** page or webpage, Licensee must also:

- Clearly and conspicuously display the **full measure rate name** once – within a list of measure rates or in a measure table. Licensee may wish to also include the following or substantially similar text in the list or table, or as a footnote in the export/report: “As [Licensee] will not have visibility into when the rates will be audited and designated reportable by an NCQA-Certified HEDIS Compliance Auditor, the “Unaudited” designation may be inapplicable.” For example:
 - When displaying a measure rate online or in an external handout, the following must be displayed: “HEDIS,” HEDIS measure set year, measure name or acronym, and applicable modifiers. For example, “**HEDIS MY 2020 Breast Cancer Screening – Uncertified, Adjusted, Unaudited HEDIS Rate.**”
